Youth Sector Staffing Reminders

Teachers in elementary schools must receive their tentative assignments for the 2023-2024 school year prior to the declaration of excess. Teachers in high schools must receive their assignments by June 15.

School Councils should be asking to see the organization for next school year and this should include: the number of groups for next year, the number of teachers required, the number of specialists allowed, etc.

Should excess be declared at your school and you feel that it is being declared in the wrong category, or that there should not be any declared in the first place, please contact Nadia as soon as excess is declared (mid-April).

Internal/Emergency Substitution (Youth Sector)

Local Negotiations



Reps from schools and centres will receive a copy of the proposed MTA demand at the Reps Assembly on April 12. Following that Reps Assembly, reps will be meeting with all teachers in their school/centre in order to share the proposed MTA demand. Reps will be voting on this proposed demand at the Reps Assembly on April 26.

Provincial Negotiations and Mobilization



The MTA has delivered "buffs" to the reps at each school and centre. We are asking teachers to wear these bright yellow buffs every Tuesday as a sign of solidarity and in support of our negotiating teams. addition, each school/centre received a set of QPAT and Negotiations flags to use in mobilization efforts. We are asking teachers each school/centre at oraanize local demonstrations 15 minutes either before school or at lunch every Tuesday. Wear your buff, wave those flags and make some noise! Delayed Implementation of the Quebec Culture and Citizenship Course

As you may have heard in the media recently, and after many interventions by the different provincial federations, including QPAT, the CAQ government has (finally) decided to delay implementation of the new Ouebec Culture and Citizenship by one year. This will allow for time to train teachers and to translate materials into English. The MTA will be pursuing discussions with the EMSB about this new course at the Educational Policies Parity Committee.

QPAT Election (2023-2025)



The QPAT Nominations Committee has confirmed the election by acclamation of:

You will receive an electronic ballot directly from Simply Voting. I encourage all MTA members to exercise their right to vote in this election.

Changes to Salary Scale on 139th Workday

Our collective agreement stipulates that our current 17-step scale is being reduced to a 16 step scale on the 139th workday of the school year (March 29th, 2023). See the column on the right of our salary scale here. Because of this reduction in the number of steps, the normal annual step advancement for July 1, 2023 is brought forward by three months to March 29th, 2023, for teachers on steps 3 to 16. If you are at step 17, when you no longer progress on the salary scale, your salary will be maintained, and you will, in future, be at step 16.

Recall that teachers on the current step 17 received a substantial increase in the previous years of the current collective agreement. Also note that for all teachers, any new salary increases we obtain from our current negotiations will apply retroactively to the 141st workday of 2023.

Youth Sector Local Ped Days 2023-2024

The 2023-2024 calendar for the Youth Sector has an addendum that reflects clause 8-5.03 of the Provincial Entente. This clause stipulates that 10% of the ped days in the youth sector (which is the equivalent of two days) are reserved for teachers to do the work they choose (ex. corrections. planning). Professional development cannot be imposed on these days. These two days are part of the moveable ped days decided at each school. The MTA strongly suggests that your council clearly identify these two days on your school calendar for 2023-2024, in order to protect these two days and for teachers to be able to determine what work they need to do on these days.

Don't forget that for all remaining local ped days, council should be consulted by the administration about any professional development being planned. Council also has the power to propose professional development activities of interest to the teachers at your school/centre.
